**State Update**

Jane asked for evidence based programs for an upcoming report. Named were the following:

Positive actions, LEAD, The Alternative Suspension Advancement Program, TAG/TAP, Tar Wars and Celebrate recovery. (Note: If anyone can think of any others, please contact Jane as she has a report due by the 13<sup>th</sup>.)

The K2 Spice (incense) purchased legally is used at Purdue currently. Curtis advised that Salvia is also on the up rise and the effects during use are very extreme. Individuals experience severe hallucinations during use.

The update has been turned in and we await approval.

The Local Coordinating Council Officers, Coordinators', ICJI, Community Consultants and community members will hold the "**Basic's of LCC**" seminar on Friday June 11, 2010 from 10:00 a.m. to 3:00 p.m. at the Indiana Government Center South Auditorium. Sessions include: Indiana codes as they pertain to your council, interpretations from ICJI legal department, review of funding procedures and policies.

Also, a short note on Face book; be careful what things you put on Face book. Very dangerous!!

Dissolvable tobacco is on the rise. (However, not in our community - More so in Indy and Plainfield.) In 06'- 08', 1,800 people consumed smokeless tobacco and taken to the hospital for poisoning. In that same time frame, 3,600 individuals were taken to the hospital for cigarette poisoning.

It was also noted that trainings were held in Vermillion/Parke clinics' for Dr and Nurses concerning pregnant girls who are still smoking. Note: 7 out of 11 patients smoke while pregnant. This often develops development and physiological problems later on.

### **Coordinator Update:**

Elaine passed the ATOD flyer for review. She would also like to set a date for the Alcohol prevention public program. (Maybe at SVHS during the health fair, LIFT or during the Hill Climb on the Courthouse lawn. (To save \$\$)

She also sent email forwards: JT Direct Weekly News, Free webinar, Parenting with the brain in mind, SAMSHA Implementing evidence – based prevention practices school, and May's Traffic safety bulletin and RAD newsletters (which Elaine put in the newspapers for Prom and graduation times) and monthly meeting press releases.

The coordinators excel spreadsheet for percentages of funding were presented. She also shared Newport's Community Center evaluation form. And, finally she is working with Mike Phelps to get the LCC website on the county website.
