	Such matters having been duly submitted and considered, the Board being sufficiently advised, finds and determines that said report is in due form and sufficient; that said road does not
	exceed three miles in length, and is, to-wit: 1 miles in length, more or less, and connects at each end with an already constructed free gravel road and is wholly within said Township; (or at one end with road and at other with Township line, or is wholly on the Township line); that it will be of public utility to improve the same as prayed for in the petition and found by said report; and, that said road should be ordered established and constructed without submitting the same to an election; that no person or corporation will be damaged by the construction of said road. And the Board further finds that more than ten (10) days
	have elapsed since the 7th day of July
(1913, the day when this Board established and ordered the construction of said road as prayed for in said petition, and that there was not during said ten (10) days, nor has there ever been, prayed or taken an appeal, nor is there now pending an appeal to
	the Circuit Court of Vermillien County by any tax-
	payer of said County of Vermillion from the decision
	of this Board ordering and establishing the construction of said road. Wherefore it is ordered and adjudged by the Board that said improvement be established and constructed as set forth in said report of the viewers and engineer and the accompanying plans, specifications and profiles, without submitting the same to an election.
	And the Board now further orders that the Auditor of Vermillion County, Indiana, give notice by publication, one time in a daily newspaper of general circulation throughout the State,
	published at Indianapolis Ind , and
	by publication for three consecutive weeks in a weekly newspaper of general circulation printed and published in Vermillion Coun-
	ty, that on the 4th day of August , 1913,
	sealed proposals will be received by said board for the making of said improvement in accordance with said profile and report, and the plans and specifications therein set forth; said notice to be
	in the Indianapelis paper shall be at
	least two weeks prior to August 4th , 1913
	All of which is considered, ordered and adjudged by the Board and this matter is continued for further proceeding.
